Therefore, the competent authority of the Board after due consideration has accorded approval for extension of Affiliation based on details/data submitted by school in online application for a further period of 5 years subject to fulfilment of following conditions:

- The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time.
- The School is required to apply on online for further extension of affiliation along with the requisite fee and other documents as per 2.
- The school will also abide by the conditions prescribed, if any, by the State Government concerned as mentioned in certificate as per 3. appendix III issued by District Education Officer (DEO) emission officer
- The school should ensure the strong governance and near adement of its activities in way of comprehensive and quantifiable planning in way of curriculum planning, infrastructure, resource of valuation, staff development and other co-curricular areas.

- Every affiliated school shall sponsor regularly its bonahits and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing well in 14. time about the non-sponsoring of the candidates. 15.
